Fee Information

Registration Fee \$100.00 – This nonrefundable fee is payable with the signed contract to secure your child's placement in The Winters' Wonderland for the **2010-2011** academic year. This annual fee is paid per child enrolled and covers supplies for the year. There will be no additional costs for expendable school supplies and local field trips.

Annual Tuition Fee

This fee represents the total tuition per child for the **2010-2011** academic year. If the annual tuition is paid in full prior to **September 1, 2010** the parents/guardian will receive a 5% discount. It is understood and agreed that in consideration for Winters' Wonderland's agreement to hold a class position for this student, the parents' obligation to pay the fees for the full academic year is unconditional. After **June 1, 2010**, no portion of the outstanding fees will be refunded or cancelled, in whole or in part, in case of absence, withdrawal, suspension, expulsion or departure from school. In addition, the parents/guardians agree to pay Winters' Wonderland for the cost of collection, including, but not limited to, reasonable attorney's fees. Any cancellation of enrollment must be in writing and received before **June 1, 2010**, to relieve the obligation of paying the tuition in full. The Registration fee is strictly nonrefundable.

Extra Hours

Winters' Wonderland may, on occasion, be open on days in which the preschool will be closed. If you would like your child to attend on these days, please check with Winters' Wonderland prior to the month in which you wish to schedule for you child to attend. The fee for these days will be **\$3.50/ hour**. The agreement to pay these fees is the same as stated for all other fees related to the preschool.

Winters' Wonderland offers two alternatives for payment of tuition.

Please mark your choice:

Alternative I – The parents/guardians agree to pay the annual tuition in one lump sum payment due and payable on or before **September 1, 2010**. If this alternative is chosen, but payment is not received by **September 1, 2010**, it is understood that parents will not receive the 5% discount and have selected Alternative II instead and are responsible for those costs. In addition, the parents/guardians agree to pay Winters' Wonderland for the cost of collection including, but not limited to, reasonable attorney's fees.

Alternative II – The parents/guardians agree to pay the tuition over a 10 month period, as stated above, with the first payment due on or before **September 1, 2010** and all subsequent payments to be made before the **1st of the month**. If parents default on the tuition we employ vigorous collection procedures to ensure payment. By signing this contract, the parents/guardians agree to pay Winters' Wonderland for all costs of collection, including, but not limited to, attorney's fees.

Other Terms and Conditions of Enrollment

- 1. School Year** – The calendar for the **2010-2011** school year is attached.
- 2. Admission Policy** – All new students entering Winters' Wonderland must comply with admission policies as established by school administration.
- 3. Parent/Teacher Communication** – As part of the partnership between families and school, the parents/guardians must come to their child's classrooms each day to collect communications and fill out attendance records.
- 4. After-School Care** – School dismisses at 11:30 a.m. for the morning class and 3:30 pm for the afternoon class to allow a time and place for teachers and parents to conference in the child's room. If the student is not picked up within 15 minutes after class is dismissed, a \$50.00 fee may be charged and we will attempt to contact the parents/guardians to arrange to have the student picked up as soon as possible.
- 5. Late Payments-** Any tuition not received by the end of the school day on the 1st of the month in which it is due will be subject to an additional fee of \$10.00 per day after the due date.
